Redwood Street - Class BD7 Beer, Wine & Liquor License - Violation of Rule 3.12 "Licensees shall operate their establishments in such a manner as to avoid disturbing the peace, safety, health, quiet, and general welfare of the community" from November 8, 2009 to date (Re: Complaints from area businesses about constant traffic and parking concerns, public intoxication, external noise from club patrons, public urination, littering and vandalism to nearby cars and properties) including the following specific dates: November 8, 2009 (Re: Police responded for an aggravated assault, additional officers needed because of unruly, intoxicated crowd in the 200 block of East Redwood Street), on November 29, 2009 (Re: Man arrested while police officer was working crowd control in 200 E.
